# ENVIRONMENTAL and SAFETY OPPOSITION to SAN RAFAEL AIRPORT RE-ZONING FOR HUGE COMPLEX

"This site's sensitivity was recognized in 1983, when the City and County agreed to allow higher-than-usual density near the freeway in order to keep the more sensitive wetlands to the east free from development. Both parcels were sold to developer Joe Shekou. Since then, his attempts to develop the eastern (airport) portion have never ceased. Although a covenant dating from 1983 restricts uses of the airport, "public and private recreation" is included among those uses, [and] city staff have argued that the complex complies with the covenant. MCL and many others view this response as unsatisfactory, citing the *intent* of the covenant, which was to limit development and human activities, not to intensify development."

### SIERRA CLUB, MARIN (www.sanfranciscobay.sierraclub.org/marin)

"[T]his two-story, Walmart-size indoor and outdoor sports complex, 184 car parking lot with outdoor lighting would put soccer playing kids within 160 feet of an active runway and flight-path. The project would bring light and noise pollution, toxic runoff, increased traffic, and excessive disturbance to the marsh and creek. It threatens sensitive habitat for the endangered California Clapper rail, salt marsh harvest mouse, black rail and steelhead trout, and other species in the Gallinas Creek watershed."

# **CENTER FOR BIOLOGICAL DIVERSITY (www.biologicaldiversity.org)**

"One of very few populations of an endangered bird -- the California clapper rail -- is under threat from a major development next to its salt-marsh habitat at Gallinas Creek. The project would crack open nine acres beside the rails' creek to construction disturbances and noise,

nighttime lighting and human-adapted predators. There are better places to put soccer fields, but very few natural homes left for clapper rails. At last count there were only 543 of these charming birds in the entire San Francisco Bay Area; the breeding population in Gallinas Creek was identified by the U.S. Fish and Wildlife Service as one of the most important in the North Bay."

"The project is located in Safety Zones 3 & 5 according to the updated Handbook. In these safety zones, the Handbook recommends prohibiting group recreational uses. In general, society gives special attention to protection of children. Special consideration should be given to facilities that cater to children such as recreation and sports facilities.
